## **GRAND RAPIDS TOWNSHIP REGULAR MEETING**

June 8, 2020

The Grand Rapids Township Trustees met at 7:00 P.M. in the Grand Rapids Township Fire Hall. Ike Topp, David Chamberlain and Rita Foos answered roll call. There were two guests.

Rita Foos moved to give Tim Van Dusen a \$.50 raise effective May 16, 2020. 2<sup>nd</sup> by Ike Topp. Roll Call YES: Ike Topp, David Chamberlain and Rita Foos. Motion carried.

Rita Foos moved to approve and dispense with the reading of the minutes, as copies were available to guests. 2<sup>nd</sup> by David Chamberlain. Roll Call YES: David Chamberlain, Ike Topp and Rita Foos. Motion carried.

The Fiscal Officer presented bills in the amount of \$3,904.98 for approval. Rita Foos moved to pay all bills as presented. 2<sup>nd</sup> by Ike Topp. Roll Call YES: Ike Topp, David Chamberlain and Rita Foos. Motion carried.

There was a discussion on the chip sealing estimates received from the County Engineer. Ike Topp mentioned that he would like to look at Labino Road. Rita Foos stated that she thought we should chip seal Beaver Creek Road. David Chamberlain said he believes that maintenance never hurts and that he feels we should chip seal Beaver Creek and Labino Roads. David Chamberlain moved to chip seal Labino Road and Beaver Creek Road for approximately \$18,000. 2<sup>nd</sup> by Rita Foos. Roll Call YES: David Chamberlain, Ike Topp and Rita Foos. Motion carried.

David Chamberlain said the he has contacted four mason contractors about tuck-pointing the mausoleum and has only received one estimate for \$5,200. Ike Topp said that he believes we should do the tuck-pointing to prevent further deterioration and that we should get the project scheduled. Ike Topp moved to hire Matt Kabacki to tuck point the mausoleum for \$5,200. 2<sup>nd</sup> by David Chamberlain. Roll Call YES: Ike Topp, David Chamberlain and Rita Foos. Motion carried.

Rita Foos mentioned that the gutter project has been completed and that the trenching project can take place.

David Chamberlain said he has contacted Mike Plotz to pour some foundations.

Rita Foos informed the Board that she was contacted by Mike Heban and informed that Mike has hired an attorney from Dayton Ohio to help him with the rules and regulations for Agribusiness. Mike informed her that he plans to make wine and serve dinners in the future and that he plans to follow all rules and regulations and is working with the health Department, Fire Marshals and Building Inspectors.
