The meeting opened with the Lord's Prayer. The minutes from the November 22, 2021 meeting were read and approved. The Fiscal Officer's report was also approved.

Dave Welling gave the Trustees copies of the pictures he took of the two abandoned houses in question in the township. Dave Welling is going to send certified letters to both property owners before asking the Health Department to deem the houses unsafe. Dave Welling did an audit of the township and only found two junk vehicles. Dave Welling relayed his discussions with the owners of the property on the corner of Devils Hole and Webster Roads.

Jim Cajka said the electricity was supposed to be on in the storage building, but all the crews were out fixing weather-related issues. Isaac Bailey contacted Zach Sarver who suggested ordering the steel for the shelter house sooner rather than later since the prices are going up.

Mark Bushman will contact Freedom Township about improving Swan Road. The Trustees discussed the tree trimming the County did. Mark Bushman will contact the County about patching Nelson Road.

There was nothing to report on the kiosk for Webster Township Cemetery. Wreaths Across America is scheduled for December 18. Mark Bushman believes the few buried stones at Webster Township Cemetery could be exposed.

Mark Bushman set up some barricades on Alexander Road, because a tree had blown onto a power line. Someone ran into one of the barricades, so Mark Bushman would like to buy a new one for the MORE grant through OTARMA.

There was nothing to report on records disposal.

Jim Cajka mentioned Jeff Dierker will refinish the floor in the township hall on January 8 and 9.

Julie Foos mentioned Brian Stickel's and Dan Sanders' terms will expire at the end of the year on the Zoning Commission and Board of Zoning Appeals. The Trustees will ask them to stay on another term.

Mark Bushman moved to accept Resolution 21-010, A Resolution Authorizing Temporary Fund Appropriations and Intra-Fund Transfers for 2022 for Webster Township, Wood County, Ohio as written. Jim Cajka seconded the motion, and all were in favor in a roll call vote.

None of the Trustees wanted to update their withholdings.

Julie Foos reported the township will received some estate tax revenue from an estate that was apparently just settled in court. Julie Foos will call Franklin County to get more details.

The next meeting has been rescheduled to December 30 at 7:30 P.M.






